- b) The candidates should report with **original certificates and Demand Draft or UTR Number for Electronic Fund Transfer through RTGS / NEFT** for the Prescribed tuition fee and other fees as specified herein below.

- a) Candidates are instructed to frequently visit the **MCC of DGHS** (Directorate General of Health Services), Ministry of Health and Family welfare, Government of India, New Delhi **Website: www.mcc.nic.in** and **College website: www.avmc.edu.in** for regular updates, counseling schedule and other information from time to time.
- b) **Provisional Allotment letter given by the MCC of DGHS for admission to MD/MS Degree programme is subject to the fulfillment of all the eligibility criteria prescribed by the National Medical Commission, New Delhi and candidate's medical fitness.** Those who fail to meet the prescribed eligibility criteria and medically unfit will not be admitted to the programme. Furthermore,

if it is found at any stage that a candidate has given false information, forged / fake certificate (or) concealed material information, his / her admission will be cancelled immediately without prior notice.

- c) All the admitted students will be governed by the rules and regulations of the University for refund policy, disciplinary procedures, hostel rules and UGC / NMC Regulations on Curbing the Menace of Ragging etc.
- d) All the disputes / arbitration arising regarding the interpretation and implementation of the provisions in this prospectus will be referred to the Vice-Chancellor, Vinayaka Mission's Research Foundation (Deemed to be University), Salem and Vice-Chancellor's decision shall be final and binding.

5) REFUND POLICY:
