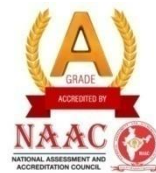

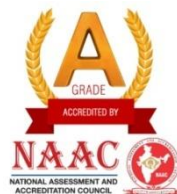
Dear Candidates,

- b) The candidates should report with **original certificates and Demand Draft** (or) UTR Number for **Electronic Fund Transfer through NEFT / RTGS** for the prescribed tuition fee and other fees as specified herein, below.
- c) i) Candidates without original certificates / documents shall **not** be allowed to take admission in the allotted Homoeopathy Medical College.
- ii) Candidates who have deposited their original certificates / documents with any other Institute / College / University and report for admission stating that “the original certificates are deposited with the respective Institute / College / University” shall **not** be allowed to take admission.
- d) Every student should pay the tuition fee and other fees, as per the University’s prescribed schedule within the due date notified.
- e) Part payment of tuition fee and other fees is not permitted.
- f) No extension of time will be given for the payment of fees (or) submission of original certificates under any circumstances.

- g) At the time of admission, the candidates and their parent /guardian should sign a declaration form / undertaking in Annexure declaring that they agree shall abide by rules and regulations of the University Including Anti-Ragging regulations of the UGC / NCH and observe the good conduct & behavior and they are bound by the University rules on payment / refund of fees.

5. IMPORTANT NOTE:

- a) Candidates are instructed to frequently visit the **AACCC** of Ministry of AYUSH, Government of India, New Delhi **website: www.aaccc.gov.in** and **College website: www.vmhmc.edu.in** for regular updates, counseling schedule and other information from time to time.
- b) **The Provisional Allotment letter issued by the AACCC, Ministry of AYUSH for admission to M.D. (Homoeopathy) Degree Programme is subject to the fulfillment of all eligibility criteria as prescribed by the National Commission for Homoeopathy (NCH) and candidate's medical fitness.** Those who fail to meet the prescribed eligibility criteria (or) medically unfit will not be admitted to the programme. Furthermore, if it is found at any stage that a candidate has given the false information, forged / fake certificates (or) concealed any material information, his/her admission will be cancelled immediately without prior notice.
- c) All the admitted students will be governed by the rules and regulations of the University for refund policy, disciplinary procedures, hostel rules and UGC/NCH Regulations on Curbing the Menace of Ragging etc.
- d) Any disputes/arbitration arising regarding the interpretation and implementation of the provisions in this prospectus will be referred to the Vice-Chancellor, Vinayaka Mission's Research Foundation (Deemed to be University), Salem and Vice-Chancellor's decision shall be final and binding.

6. REFUND POLICY:

We are aware and agree that, the following refund policy shall be strictly implemented by the constituent colleges of Vinayaka Mission's Research Foundation (Deemed to be University), Salem, Tamil Nadu.

1	In case of re-allocation / upgradation during the Round 2 / 3 of counseling.	No fee will be deducted.
2	In case of resignation after the firstround of counseling	Rs. 25,000/- will be deducted.
3	If any candidate resigns / withdraws after round 2 of counseling.	No refund of Tuition fee & Other fees.
4	If any candidate resigns / withdraws from the course that results in rendering the seat vacant.	First year fees paid will be forfeited and students should pay the 'entire course fees' for the remaining years of the programme periods.
5	In all cases not covered under condition in column above, the amount of fees payable. (where the seat is rendered vacant without having any chance of being filled up with any other candidates)	The entire fees paid by the candidates will be forfeited. In addition, the candidates shall be required to remit the 'entire Programme fees' for the remaining years of the programme periods
