INSTRUCTIONS TO THE CANDIDATES

Vinayaka Mission's Research Foundation (Deemed to be University) offers Institutional Scholarships / Fee Concessions / Freeships and Fee waiver to recognize and reward meritorious students. The Scholarships / Concessions / Freeships are awarded to students as per the categories listed. These Scholarships / Concessions / Freeships are given every year to help young aspiring students to pursue higher education and advanced studies. This is to aim with the Mission and vision of VMRF-DU to provide opportunities to deserving candidates to undertake advanced studies and research. The quantum of scholarship and the number of scholarships are subject to change from time to time and according to the programmes.

Scholarships Procedure :

1. Selection

- a) Every year all eligible students have to apply for Fresh and Renewal of the scholarship in the prescribed form available in the University / College office / Website.
- b) Application forms for request of scholarship for renewal (Second Year to Final Year) will be received from May to tile 31st July of every year. Fresh application (First Year) will be received till last date of admission.
- c) A Student can apply and avail ONLY ONE scholarship scheme.
- d) The eligible students will be informed through the Head of the Institution.
- e) The above scholarships are for the regular Full time programme students only.

2. Guidelines of Second year to final year Scholarships :

All the above scholarships are renewed every year subject to academic performance of the student in the previous academic year of VMRF-DU Examinations with above 9.0 SGPA (without any break of study). It will also be subject to discipline and maintenance of attendance at least 75% by the Student. In such case, student would get the same amount of scholarship which was provided in the previous year.

The Second year to final year students who are not availed any scholarship category during admission time and if they wish to apply based on the VMRF-DU Examinations with above 9.0 SGPA and above are eligible to get only 20% scholarship in Tuition fees for that year

3. Not Eligible for Scholarship

Students for the following categories are not eligible for any scholarship / any year during the period of study.

- ❖ Break of Study
- ❖ Failure in the VMRF-DU examination
- ❖ Less than 75% of attendance
- ❖ Disciplinary action / Enquiry / Suspension
- ❖ Failure to apply for scholarship within the stipulated date will not be eligible for the scholarship.

Note :

- Students applying for the award of scholarship shall submit the proof of annual income certified by the appropriate Government authority / from the employer of parents.
- In all matters connected with or arising from the above, the decision of the Vice-Chancellor of VMRF- DU shall be final.
