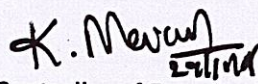
Instructions to the Candidates

- I. The fee once paid will not be refunded or adjusted under any circumstances.
- II. Applications after the stipulated date will not be entertained on any grounds.
- III. The fees should be paid by the students through **online payment** on or before the stipulated time.
- IV. Students on roll have to pay the examination fee by online payment mode through Mycamu by individual login. For first time, Students have to download Mycamu app from playstore and register by getting PIN from college for the online payment student's email and contact number to be utilized and this can be updated by the students themselves in Mycamu. After entering, it must be approved by the admission section of the respective college to enable the students to make payment online through paytm. Students have to select the current exam month fee only before making payment.
- V. Those candidates who have shortage of Attendance and have not obtained minimum Internal marks are not eligible for appearing the examination even if they have paid examination fee through online.

Instructions to the Dean/Principal / Head of Institutions

Remittance of Examination Fee:

1. All applications for registration should be accompanied by the prescribed fee payment evidence.
2. Those candidates who have shortage of Attendance and have not obtained minimum marks in Internal Assessment are not eligible for appearing the examination. If there is any deviation, Dean/Principal/ Head of Institution are solely responsible for any lapses in this regard.
3. No other fees should be collected from the candidates for this examination purpose.
