Instructions to the Candidates

Students have to download mycamu app from playstore and register by getting PIN from college for the online payment student's email and contact number to be utilized and this can be updated by the students themselves in Mycamu. After entering it must be approved by the admission section of the respective college to enable the students to make payment online through paytm.
