The details submitted in the online application / registration form shall be treated as correct and self-certified. Vinayaka Mission's Research Foundation (Deemed to be University), Salem will not entertain any requests for correction or modification of the submitted information under any circumstances.

3) ONLINE FILLING OF APPLICATION FORM:

- a) Application forms are available only in online mode. Candidates should fill in all details carefully and submit the application online along with scanned copies of H.Sc. / Degree Mark sheet(s), Degree / Provisional certificate photograph and signature as attachments.
- b) The information provided in the online application form, such as candidate's Name, Parent/Guardian details, Date of Birth, Gender, Educational qualification, Community/Category, Address and Contact details, will be treated as final and self-certified. No changes or modifications will be permitted after submission of application. Any request for correction / changes will not be considered by VMRF (DU). Candidates must ensure all details entered are correct before submission.
- c) All admission-related information, including Rank and Counseling Intimation Letter etc., will be available only through the Application Portal. Candidates are advised to keep their Application Number for future reference. No separate communication will be sent through e-mail or SMS.
- d) Candidates are advised to visit the University website (www.vmrfd.edu.in) regularly for updates, from the date of application submission until the completion of the admission process. The University will not be responsible for any consequences arising due to failure to check notifications related to UG admissions for the academic year 2026–2027.
- e) Candidates who are unable to submit the online application independently may approach at the constituent institution of Vinayaka Mission's College of Physical Education, Salem or the Admission Section of VMRF (Deemed to be University), Salem, along with their Parents/Guardian and original certificates, for assistance
- f) Incomplete online applications will not be accepted.

4) ELIGIBILITY CERTIFICATE:

Candidates from other Boards / Universities / Countries (except Tamil Nadu State Board, CBSE / ICSE, New Delhi and VMRF(DU)) who wish to seek admission to the UG, PG Degree & Diploma Programmes in the constituent college of Vinayaka Mission's Research Foundation (Deemed to be University), Salem, must obtain an Eligibility Certificate from this University and submit at the time of admission.

5) COUNSELING CALL LETTER:

- a) All eligible candidates can download the Counseling Call Letter from the University Application Portal.
- b) Candidates must produce the Counseling Call Letter at the time of counseling. No candidate will be allowed to attend counseling without the call letter.
- c) Mere participation in counseling does not confer any right to admission. Candidates who do not fulfill the prescribed eligibility criteria will not be considered for admission.

6) COUNSELING CENTRE:

Counseling will be conducted at:

7) MODE OF SELECTION:

- a) Selection will be based on the marks obtained in the qualifying examination and selection trials for B.P.E.S., B.P.Ed., & M.P.E.S. courses through merit-based counseling conducted by the Admission Monitoring Committee (AMC) of VMRF (Deemed to be University), Salem, in accordance with the eligibility criteria prescribed by the UGC, National Council Council for Teacher Education, New Delhi and VMRF (DU) rules and regulations.
- b) Intimation Letters will be sent by e-mail to candidates who are provisionally selected for admission.
- c) In case of two or more candidates secure the same marks in the qualifying examination, the inter-se ranking will be determined based on their academic performance for admission purposes.
- d) Candidates must upload their H.Sc. / Degree Mark Sheet(s) in the Application Portal; failure to do so may result in loss of rank position in the merit list.
- e) Results will be published on the University website: www.vmrfd.edu.in and displayed on the University Notice Board.

8. Nativity Certificate / Domicile Certificate
9. 10th Std. Mark Sheet
10. Copy of Aadhaar Card of the Candidate.
11. Medical Fitness Certificate
12. Recent passport- size colour photographs - 9 Nos. (taken after 1st January 2026)

Note: Candidates must ensure that their name and date of birth are identical in both their School Certificates and Aadhaar Card.

9) ANTI-RAGGING MEASURES:

Ragging is strictly prohibited on all campuses of Vinayaka Mission's Research Foundation (Deemed to be University). The University strictly enforces Anti-ragging measures and ensures that the campus is free from any form of ragging.

Any violation will be dealt with strictly in accordance with the law in force and as per the directions of the Hon'ble Supreme Court of India, UGC, National Council for Teacher Education, New Delhi and VMRF(DU).

10) RULES ON DISCONTINUANCE FROM PROGRAMME OF STUDY:

- a) If a student discontinues the course after the cut-off date prescribed by the statutory authorities/university, or if the seat remains vacant without the possibility of being filled by another candidate, the student shall be liable to pay the applicable tuition fee and other fees as per University regulations.
- b) All students and their parents must submit a written declaration agreeing to these conditions at the time of admission.

11) IMPORTANT NOTE:

- a) All admissions are subject to fulfillment of the prescribed eligibility conditions by the candidate. If, at the time of admission (or) at any stage, it is found that the candidate has furnished false information, submitted forged certificates (or) concealed material information, the admission shall be cancelled and the student will be dismissed from the institution immediately.
- b) The fee refund policy is followed as per UGC guidelines.
- c) VMRF (Deemed to be University) reserves the right to amend or modify the curriculum, course structure, rules, regulations, admission procedures, examinations, fee structure, and refund policy as deemed necessary.
- d) Students will be governed by University rules including those relating to fee refund, discipline and hostel rules.
- e) All disputes arising from the interpretation of this prospectus will be referred to the Vice-Chancellor of the University, whose decision shall be final and binding.
- f) All legal matters arising out of this prospectus shall fall under the jurisdiction of the Courts in Salem only.
