Candidates should ensure that all information entered in the online application is correct and factual during the online submission of application form. The details provided in the online application / registration form shall be treated as correct and self-certified, and Vinayaka Mission's Research Foundation (Deemed to be University), Salem will not entertain any requests for correction or modification of the submitted information under any circumstances.

2) ELIGIBILITY FOR ENTRANCE EXAMINATION:

a)

Sl. No.	Name of the Programme	Eligibility
1	M. Pharm	A pass in B.Pharm Degree Programme from a recognized University with a minimum aggregate of 55% marks, in the case SC/ST/OBC category shall be 50% marks.
2	Pharm. D	A pass in B.Pharm Degree Programme or its equivalent qualification from a recognized University.

- b) Candidates should have obtained permanent registration in any State Pharmacy Council.
- c) Candidates appearing for final year B.Pharm Degree examination in the year 2026 are also eligible to apply for the Entrance Examination.
- d) Selection of candidates will be based on merit in the Entrance Examination

3) ONLINE FILLING OF APPLICATION FORM:

- a) Application forms are available only in online mode. Candidates should fill in all details carefully and submit the application online along with scanned copies of B.Pharm Degree / Provisional Certificate / Mark Sheet(s), Photograph and Signature as attachments.
- b) The Registration fee of **Rs.1,000/-**(Rupees One Thousand Only) paid at the time of submitting the online application is non-refundable under any circumstances.
- c) During online registration, all candidates should upload the B.Pharm Degree / Provisional Certificate / Mark Sheet(s) on or before **14.08.2026**. If a candidate fails to upload the above Degree / Provisional certificate / Mark Sheet(s) to the University within the stipulated time, his / her ranking will be fixed as specified in this prospectus.
- d) All Entrance Examination related communications, such as Hall Ticket, Results and Counseling Intimation letter etc., will be made available only through the Application Portal. Therefore, candidates are advised to keep their application number for future reference. No separate communication will be sent via individual e-mail or SMS.
- e) Candidates are advised to visit our University website: **www.vmrfd.edu.in** regularly for updates from the date of submission of the online application until the completion of the admission process without fail. VMRF (Deemed to be University) shall not be responsible for any consequences arising due to failure to regularly check notices, notifications or publications related to the Entrance Examination for the 2026-2027 session.
- f) Candidates who are unable to apply the online application independently may approach the Vinayaka Mission's College of Pharmacy, Salem or Admission Section of VMRF (Deemed to be University), Salem, with their Parents / Guardian and all original certificates to avail assistance for applying the online application.
- g) Incomplete online application forms will not be accepted.

4) HALL TICKET:

- a) The Entrance Examination Hall Ticket can be downloaded from the University's Entrance Examination Application Portal.
- b) **Candidates must produce the Hall Ticket at the Entrance Examination Centre without fail. No candidate will be permitted to write the Entrance Examination without a Hall Ticket.**
- c) Mere acceptance of a candidate for writing the Entrance Examination does not confer any right or eligibility for admission. Candidates who do not fulfill the prescribed eligibility criteria will not be considered for admission.

- d) Candidates are strictly **not allowed** to carry any textual material (printed or written), bits of paper or any prohibited items such as pen, pencil, calculator, mobile phone or any electronic devices that may provide unfair assistance inside the examination hall. Pen, pencil and eraser will be provided to the candidates at the examination centre.
- e) Candidates shall not be permitted to leave the examination hall until the completion of Entrance Examination.
- f) Candidates shall maintain complete silence and attend only to their examination papers. Any form of conversation, gesticulation (or) disturbance inside the examination hall will be treated as misbehavior. If a candidate is found indulging in misbehavior, using unfair means (or) resorting to impersonation, his / her candidature will be cancelled and he/she shall be debarred from appearing in any Entrance Examination conducted by the VMRF (Deemed to be University).
- g) Candidates must hand over the OMR answer sheet along with the question booklet to the invigilator after completion of the Entrance Examination. Failure to do so will result in cancellation of candidature.

5) ENTRANCE EXAMINATION CENTRE:

The All India Entrance Examination will be conducted at **Salem**. The Venue will be intimated in the Hall Ticket.

6) DURATION OF ENTRANCE EXAMINATION AND QUESTION PATTERN:

- a) The All India Entrance Examination is being conducted in **English** only. The question booklet will consist of 100 Multiple Choice Questions (MCQs), each carrying one correct (single best) response.
- b) The Maximum marks for the Entrance Examination shall be 100, with one mark awarded for each question. The duration of the examination is two (2) hours.
- c) All questions must be answered and each question carries equal marks. There shall be no negative mark for incorrect answers. The correct answer must be shaded with a Pencil in the OMR answer sheet provided along with the question booklet.
- d) Candidates are advised to report to the Examination Centre at least one hour before the commencement of the Examination.
- e) Syllabus: The Entrance Examination will be based on the B.Pharm Degree syllabus prescribed by the major Universities.

7) MODE OF SELECTION:

- a) Selection shall be made based on the marks secured by the candidates in the All India Entrance Examination and merit based counseling conducted by the Admission Monitoring Committee (AMC) of VMRF (Deemed to be University), Salem. The intimation letter will be sent to the candidates provisionally selected for admission by e-mail.
- b) In case of two or more candidates securing the same marks in the Entrance Examination, the inter-se ranking shall be determined based on their academic performance in the qualifying examination prescribed for admission.
- c) To facilitate the ranking process mentioned above, candidates should upload a copy of their B.Pharm Degree / Provisional certificate / Mark Sheet(s) on (or) before **14.08.2026** (or) submit the same to the Director (Admissions), VMRF (Deemed to be University), Salem in person (or) by e-mail (or) by Courier. Failure to do so will result in loss of rank position in the merit list as specified in sub-clause (b).
- d) The Entrance Examination results will be published on the University website: **www.vmrfd.edu.in** and also displayed on the University Notice Board.

8) ELIGIBILITY CERTIFICATE

Candidates who have passed the qualifying degree from any university other than Vinayaka Mission's Research Foundation (Deemed to be University), Salem, Tamil Nadu must obtain an Eligibility Certificate from VMRF(DU) before joining the course

9) DOCUMENTS TO BE PRODUCED AT THE TIME OF COUNSELING:

- a) Candidates are required to produce the following documents **in original along with scanned copies and the required photocopies**, at the time of counseling.

10) ANTI-RAGGING MEASURES:

- b) VMRF (Deemed to be University) reserves the right to amend or modify the curriculum, course structure and the rules & regulations relating to admission, examinations, fee structure, refunds etc., as and when deemed necessary.
- c) All disputes arising out of the interpretation and implementation of the provisions of this prospectus shall be referred to the Vice-Chancellor of this University, whose decision shall be final and binding.
